Experiments with animals also indicate that indium may cause reduced food and water consumption with weight loss, pulmonary edema, pneumonia, blood, liver and kidney damage, leg paralysis and damage to the brain, heart, adrenals and spleen.

Metallic tin and inorganic tin compounds may cause nausea, vomiting, diarrhea, irritation and pneumoconiosis.
